## **School Courses for the Exchange of Data (SCED v.5)**

Purpose: School Courses for the Exchange of Data (SCED) is a voluntary, common classification system for prior-to-secondary and secondary school courses. It can be used to compare course information, maintain longitudinal data about student coursework, and efficiently exchange coursetaking records. The SCED Working Group published SCED Version 5 in November 2017 as a sortable, downloadable file available on the Forum SCED webpage (<https://nces.ed.gov/forum/SCED.asp>). Version 5 focused on updates to Subject Area 5: Visual and Performing Arts—in particular, new media arts courses—and Project Lead the Way, Advanced Placement, and International Baccalaureate courses.

## **SCED Resources: Master List, Finder**

Following the release of SCED Version 5, the Forum also updated the SCED Finder tool. This tool was originally released with SCED Version 3 and has since been revised to reflect new and updated SCED Version 5 courses. SCED Finder helps users select SCED codes and then assign elements and attributes to those codes. Users can search SCED using keywords or browse the entire SCED to find the appropriate course code. The tool allows users to create, edit, and export lists of courses with the selected course code and user-identified SCED elements. SCED Finder was developed through the collaboration of the Forum and the National Center for Education Statistics Transcript Studies.

## **Forum Video: School Courses for the Exchange of Data (SCED): Course Coding**

Purpose: The SCED Working Group developed this video to explain course coding with SCED. The video begins by explaining the coding elements that make up SCED, including Course Code, Course Level, Available Carnegie Unit Credit (or Grade Span for prior-to-secondary courses), and Sequence of Course. It then illustrates the use of optional elements, called attributes, which SEAs and LEAs can add if they need to communicate additional information about a course. The video is the second in a series; the first video provided an introduction to SCED, and the third video will focus on SCED resources.

## SCED Working Group

Purpose: SCED provides voluntary, common course codes for prior-to-secondary and secondary school courses that can be used to compare course information, maintain longitudinal data about student coursework, and efficiently exchange coursetaking records. SCED must reflect up-to-date course offerings to remain relevant, and the Forum SCED Working Group is tasked with reviewing and revising SCED to ensure that it is up to date and accurate, while also maintaining the established structure and integrity of the course codes. The Working Group is collaborating with subject matter experts and SCED users to review and update existing courses and identify new courses for SCED Version 6. In addition to updated course codes, the Version 6 release will include new SCED Finder search features; an updated Master List of all SCED codes and changes over time; and resources to help SCED users, such as case studies, a new video, and new frequently updated questions.

## Forum Virtual Activities

As part of the Communications Subcommittee's effort to improve communication between Forum members and partner organizations, the Forum has held webinars with the National Center for Education Statistics (NCES), the Common Education Data Standards (CEDS), the Regional Educational Laboratory (REL) Program, the Statewide Longitudinal Data Systems (SLDS) Grant Program, and the Privacy Technical Assistance Center (PTAC).

### The Role and Impact of Technology on Education: The NCES ED TECH Equity Initiative

Halima Adenegan, National Center for Education Statistics, delivered a virtual presentation to the Technology Committee on September 13, 2017. Halima provided information about the NCES ED TECH Equity Initiative and received feedback on the Initiative from Forum members.

## Joint Webinars

The Forum strives to collaborate and coordinate with multiple groups such as the SLDS Grant Program, PTAC, the REL program, and others to provide helpful information on topics of interest to education agencies.

- Representatives from the Forum, PTAC, the REL program, and the SLDS Grant Program participated in a joint webinar, *Student Data in Times of Crisis: Collecting and Managing Data of Displaced Students*, on December 18, 2017 to provide helpful information for state and local education agencies dealing with displaced students due to extreme weather events or other crises. They discussed how to manage data for students moving into or out of an agency, privacy considerations, practitioners' perspectives, and contact information for additional support. - Representatives from the Forum, PTAC, the REL network, and the SLDS Grant Program participated in a joint webinar, *Increasing Education Data Use through SEA, LEA, and Researcher Partnerships*, on June 5, 2018 to provide helpful information for state and local education agencies interested in working with researchers. They discussed how to successfully collaborate with researchers on projects that reflect education agency information needs, privacy considerations, practitioners' perspectives, and contact information for additional support.
