LETTER FROM THE CHAIR

Welcome to 2021, Forum members!

It should go without saying that at the time of last year's newsletter, none of us could have had any idea what the world would look like right now. 2020 proved to be an eventful year, to say the very least. The education world was rapidly and drastically reshaped by the sudden emergence of the coronavirus disease (COVID-19) pandemic, in ways that teachers, students, families, and education professionals will be reckoning with for years to come. But the Forum kept on rolling through all of it—it's heartening for me to look back at what we accomplished together during such a turbulent time. I hope it will be the same for you.

When schools and districts were forced to close their doors to students in the spring of 2020, with little notice and varying ability to make a successful transition to remote learning and teaching, the Forum stepped up to support their efforts with our resources and expertise. One service we provided, to immediate practical benefit, was a running list of the reopening plans developed by states. NEW FORUM RESOURCES

- ***Forum Guide to Data Governance***
The *Forum Guide to Data Governance* highlights how data governance programs benefit education agencies, and provides timely and useful best practices, examples, and resources for agencies implementing or updating their data governance programs. This resource provides an overview of data governance; discusses effective data governance practices, structures, and essential elements; and describes how to meet privacy and security requirements while also meeting data accessibility and sharing needs. It includes detailed case studies that offer an in-depth look at the challenges, successes, and lessons learned from education agencies in their data governance efforts.
- ***Forum Guide to Exit Codes***
The *Forum Guide to Exit Codes* provides best practice information for tracking data about when students transferred, completed high school, dropped out, or otherwise exited an education agency. As such, this resource defines exit codes and reviews their use in an education agency; provides an updated, voluntary, common taxonomy for exit codes; discusses best practices and methods for addressing specific challenges in exit codes data collection; and features case studies that highlight different education agencies' approaches to and experiences with exit coding. This resource updates the information included in the 2006 publication *Accounting for Every Student: A Taxonomy for Standard Student Exit Codes*.
- ***Forum Guide to Cybersecurity: Safeguarding Your Data***
The *Forum Guide to Cybersecurity: Safeguarding Your Data* is intended to help agencies proactively prepare for, appropriately mitigate, and responsibly recover from a cybersecurity incident. The document provides timely and useful best practice information to help protect agency systems and data before, during, and after a cybersecurity incident. Case studies from states and districts that have planned proactively for or experienced a cybersecurity incident are included.
- ***School Courses for the Exchange of Data (SCED) Version 8 and related resources***
The Forum's SCED Working Group published *SCED Version 8* in September 2020. This new version includes new and updated courses that were suggested by SCED users and subject matter experts in federal, state, and local education agencies. Following the release of *SCED Version 8*, the SCED Working Group also updated the SCED Master List and the SCED Finder tool with new and updated courses. SCED Finder helps users select SCED

codes and assign elements and attributes to those codes; search SCED using keywords; browse the entire SCED; and create, edit, and export lists of courses. *SCED Version 8* (as a sortable, downloadable file), SCED Finder, SCED videos, and other SCED resources are all available at <http://nces.ed.gov/forum/SCED.asp>.

- ***Forum Guide to SCED Uses and Benefits***

The *Forum Guide to SCED Uses and Benefits* is designed to provide timely and useful best practice information to help education agencies understand the different uses and benefits of SCED. This guide was developed to provide a brief overview of SCED, highlight the research application and benefits of SCED to users, and illustrate SCED uses with case studies. This new resource was developed to supplement the suite of SCED resources currently available at <http://nces.ed.gov/forum/SCED.asp>. The content of this guide builds on previous work, including the 2014 *Forum Guide to SCED Classification System* and several case studies and videos highlighting how to use SCED.



FORTHCOMING FORUM RESOURCES

The Forum has had a productive year, with projects on data visualization, staff records, data strategies, and SCED nearing completion. Four new Forum resources will be published in the coming months:

- **Data Visualization Online Course Module 2: Applied Data Visualization**

The Data Visualization Online Course Module 2: Applied Data Visualization demonstrates the effective application of data visualization to common education topics through scenarios that highlight recommended best practices. The second module builds upon the concepts presented in [Module 1: Introduction to Data Visualization](#) and includes a voluntary assessment of course content mastery for learners who wish to receive proof of course completion.

- ***Forum Guide to Staff Records***

The *Forum Guide to Staff Records* updates information from the 2000 Forum resource, [Privacy Issues in Education Staff Records: Guidelines for Education Agencies](#). The new resource provides an overview of the many types of information that may be classified as staff records; effective practices for collecting, maintaining, and protecting the privacy of these records; and information on managing access to the records, including open records requests.

- ***Forum Guide to Strategies for Education Data Collection and Reporting (SEDCAR)***

The *Forum Guide to SEDCAR* was created to provide timely and useful best practices for education agencies that are interested in designing and implementing a strategy for data collection and reporting, focusing on these as key elements of the larger data process. It builds upon the [Standards for Education Data Collection and Reporting](#) (published by the Forum in 1991) and reflects the vast increase over the past three decades in the number of compulsory and/or continual data collections conducted by education agencies. This new resource is designed to be relevant to the SEAs and LEAs of today, in which data are regularly collected for multiple purposes, and data collection and recording may be conducted by many different individuals within an agency.

- **SCED Video 4: SCED Finder**

SCED Video 4: SCED Finder demonstrates how to use SCED Finder to search and browse SCED codes; build a complete, 12-character SCED Identifier; and create a list of courses that can be saved and downloaded. The video is the fourth in a series; the first video introduced SCED, the second provided an overview of SCED coding, and the third introduced resources developed by the Forum to communicate information about SCED and assist SCED users.
