


The National Assessment of Educational Progress (NAEP) assesses science in two major dimensions: Fields of Science (Earth, Physical, and Life) and Knowing and Doing Science (Conceptual Understanding, Scientific Investigation, and Practical Reasoning). The NAEP science scale ranges from 0 to 300. Scales are created separately for each grade.

Overall Science Results for Hawaii

- In 2005, the average scale score for fourth-grade students in Hawaii was 142. This was higher than their average score in 2000 (136).¹
- Hawaii's average score (142) in 2005 was lower than that of the nation's public schools (149).
- Of the 44 states and one jurisdiction that participated in the 2005 fourth-grade assessment, students' average scale score in Hawaii was higher than those in 2 jurisdictions, not significantly different from those in 5 jurisdictions, and lower than those in 37 jurisdictions.²
- The percentage of students in Hawaii who performed at or above the NAEP *Proficient* level was 19 percent in 2005. This percentage was not significantly different from that in 2000 (16 percent).
- The percentage of students in Hawaii who performed at or above the NAEP *Basic* level was 57 percent in 2005. This percentage was greater than that in 2000 (51 percent).



Average Score Gaps Between Selected Groups

- In 2005, male students in Hawaii had an average score that was not significantly different from that of female students. In 2000, there was no significant difference between the average score of male and female students.
- In 2005, Black students had an average score that was lower than that of White students by 21 points. In 2000, there was no significant difference between the average score of Black and White students (gap of 13 points).
- In 2005, Hispanic students had an average score that was lower than that of White students by 17 points. Data are not reported for Hispanic students in 2000, because reporting standards were not met. Therefore, the performance gap results are not reported.
- In 2005, students who were eligible for free/reduced-price school lunch, an indicator of poverty, had an average score that was lower than that of students who were not eligible for free/reduced-price school lunch by 20 points. In 2000, the average score for students who were eligible for free/reduced-price school lunch was lower than the score of those not eligible by 25 points.
- In 2005, the score gap between students at the 75th percentile and students at the 25th percentile was 43 points. In 2000, the score gap between students at the 75th percentile and students at the 25th percentile was 45 points.

Science Scale Scores at Selected Percentiles



Scores at selected percentiles on the NAEP science scale indicate how well students at lower, middle, and higher levels performed.

¹ Comparisons (higher/lower/not different) are based on statistical tests. The .05 level was used for testing statistical significance. Comparisons across jurisdictions and comparisons with the nation or within a jurisdiction across years may be affected by differences in exclusion rates for students with disabilities (SD) and English language learners (ELL). The exclusion rates for SD and ELL in Hawaii were 2 percent and 1 percent in 2005, respectively. Statistical comparisons are calculated on the basis of unrounded scale scores or percentages.

² "Jurisdiction" refers to states and the Department of Defense Education Activity schools.
