


The National Assessment of Educational Progress (NAEP) assesses mathematics in five content areas: number properties and operations; measurement; geometry; data analysis and probability; and algebra. The NAEP mathematics scale ranges from 0 to 500.

Overall Mathematics Results for Hawaii

- In 2005, the average scale score for fourth-grade students in Hawaii was 230. This was higher¹ than their average score in 2003 (227), and was higher than their average score in 1992 (214).
- Hawaii's average score (230) in 2005 was lower than that of the Nation's public schools (237).
- Of the 52 states and other jurisdictions² that participated in the 2005 fourth-grade assessment, students' average scale scores in Hawaii were higher than those in 4 jurisdictions, not significantly different from those in 7 jurisdictions, and lower than those in 40 jurisdictions.
- The percentage of students in Hawaii who performed at or above the NAEP *Proficient* level was 27 percent in 2005. This percentage was not significantly different from that in 2003 (23 percent), and was greater than that in 1992 (15 percent).
- The percentage of students in Hawaii who performed at or above the NAEP *Basic* level was 73 percent in 2005. This percentage was greater than that in 2003 (68 percent), and was greater than that in 1992 (52 percent).



Average Score Gaps Between Selected Groups

- In 2005, male students in Hawaii had an average score that was not found to be significantly different from that of female students. In 1992, there was no significant difference between the average score of male and female students.
- In 2005, Black students had an average score that was lower than that of White students by 21 points. In 1992, the average score for Black students was lower than that of White students by 18 points.
- In 2005, Hispanic students had an average score that was lower than that of White students by 23 points. In 1992, the average score for Hispanic students was lower than that of White students by 16 points.
- In 2005, students who were eligible for free/reduced-price school lunch, an indicator of poverty, had an average score that was lower than that of students who were not eligible for free/reduced-price school lunch by 18 points. In 1996, the average score for students who were eligible for free/reduced-price school lunch was lower than the score of those not eligible by 23 points.
- In 2005, the score gap between students at the 75th percentile and students at the 25th percentile was 39 points. This performance gap was narrower than that of 1992 (46 points).

Scores at selected percentiles on the NAEP mathematics scale indicate how well students at lower, middle, and higher levels of the distribution performed.

¹ Comparisons (higher/lower/not different) are based on statistical tests. The .05 level was used for testing statistical significance. Performance comparisons may be affected by differences in exclusion rates across years for students with disabilities (2% nationally in 2005) and English language learners (1% nationally in 2005) in the NAEP samples. Statistical comparisons are calculated on the basis of unrounded scale scores or percentages.

² "Other Jurisdictions" refers to the District of Columbia and the Department of Defense Education Activity schools.
