


The National Assessment of Educational Progress (NAEP) assesses mathematics in five content areas: number properties and operations; measurement; geometry; data analysis and probability; and algebra. The NAEP mathematics scale ranges from 0 to 500.

Overall Mathematics Results for Indiana

- In 2005, the average scale score for eighth-grade students in Indiana was 282. This was not significantly different from¹ their average score in 2003 (281), and was higher than their average score in 1990 (267).
- Indiana's average score (282) in 2005 was higher than that of the Nation's public schools (278).
- Of the 52 states and other jurisdictions² that participated in the 2005 eighth-grade assessment, students' average scale scores in Indiana were higher than those in 23 jurisdictions, not significantly different from those in 20 jurisdictions, and lower than those in 8 jurisdictions.
- The percentage of students in Indiana who performed at or above the NAEP *Proficient* level was 30 percent in 2005. This percentage was not significantly different from that in 2003 (31 percent), and was greater than that in 1990 (17 percent).
- The percentage of students in Indiana who performed at or above the NAEP *Basic* level was 74 percent in 2005. This percentage was not significantly different from that in 2003 (74 percent), and was greater than that in 1990 (56 percent).



Average Score Gaps Between Selected Groups

- In 2005, male students in Indiana had an average score that was not found to be significantly different from that of female students. In 1990, the average score for male students was higher than that of female students by 5 points.
- In 2005, Black students had an average score that was lower than that of White students by 29 points. In 1990, the average score for Black students was lower than that of White students by 28 points.
- In 2005, Hispanic students had an average score that was lower than that of White students by 25 points. Data are not reported for Hispanic students in 1990, because reporting standards were not met. Therefore, the performance gap data are not reported.
- In 2005, students who were eligible for free/reduced-price school lunch, an indicator of poverty, had an average score that was lower than that of students who were not eligible for free/reduced-price school lunch by 22 points. In 1996, the average score for students who were eligible for free/reduced-price school lunch was lower than the score of those not eligible by 25 points.
- In 2005, the score gap between students at the 75th percentile and students at the 25th percentile was 43 points. In 1990, the score gap between students at the 75th percentile and students at the 25th percentile was 44 points.

Scores at selected percentiles on the NAEP mathematics scale indicate how well students at lower, middle, and higher levels of the distribution performed.

¹ Comparisons (higher/lower/not different) are based on statistical tests. The .05 level was used for testing statistical significance. Performance comparisons may be affected by differences in exclusion rates across years for students with disabilities (3% nationally in 2005) and English language learners (1% nationally in 2005) in the NAEP samples. Statistical comparisons are calculated on the basis of unrounded scale scores or percentages.

² "Other Jurisdictions" refers to the District of Columbia and the Department of Defense Education Activity schools.
