


The National Assessment of Educational Progress (NAEP) assesses mathematics in five content areas: number properties and operations; measurement; geometry; data analysis and probability; and algebra. The NAEP mathematics scale ranges from 0 to 500.

Overall Mathematics Results for Louisiana

- In 2007, the average scale score for eighth-grade students in Louisiana was 272. This was higher than their average score in 2005 (268) and was higher than their average score in 1990 (246).¹
- Louisiana's average score (272) in 2007 was lower than that of the nation's public schools (280).
- Of the 52 states and other jurisdictions that participated in the 2007 eighth-grade assessment, students' average scale score in Louisiana was higher than those in 5 jurisdictions, not significantly different from those in 8 jurisdictions, and lower than those in 38 jurisdictions.²
- The percentage of students in Louisiana who performed at or above the NAEP *Proficient* level was 19 percent in 2007. This percentage was not significantly different from that in 2005 (16 percent) and was greater than that in 1990 (5 percent).
- The percentage of students in Louisiana who performed at or above the NAEP *Basic* level was 64 percent in 2007. This percentage was not significantly different from that in 2005 (59 percent) and was greater than that in 1990 (32 percent).



Average Score Gaps Between Selected Groups

- In 2007, male students in Louisiana had an average score that was not significantly different from that of female students. In 1990, there was no significant difference between the average score of male and female students.
- In 2007, Black students had an average score that was lower than that of White students by 25 points. In 1990, the average score for Black students was lower than that of White students by 30 points.
- Data are not reported for Hispanic students in 2007, because reporting standards were not met. Therefore, the performance gap results are not reported.
- In 2007, students who were eligible for free/reduced-price school lunch, a proxy for poverty, had an average score that was lower than that of students who were not eligible for free/reduced-price school lunch by 20 points. In 1996, the average score for students who were eligible for free/reduced-price school lunch was lower than the score of those not eligible by 24 points.
- In 2007, the score gap between students at the 75th percentile and students at the 25th percentile was 40 points. In 1990, the score gap between students at the 75th percentile and students at the 25th percentile was 44 points.

¹ Comparisons (higher/lower/narrower/wider/not different) are based on statistical tests. The .05 level was used for testing statistical significance. Statistical comparisons are calculated on the basis of unrounded scale scores or percentages. Comparisons across jurisdictions and comparisons with the nation or within a jurisdiction across years may be affected by differences in exclusion rates for students with disabilities (SD) and English language learners (ELL). The exclusion rates for SD and ELL in Louisiana were 3 percent and "percentage rounds to zero" in 2007, respectively. ² "Jurisdictions" refers to states and the District of Columbia and the Department of Defense Education Activity schools.
