


The National Assessment of Educational Progress (NAEP) assesses mathematics in five content areas: number properties and operations; measurement; geometry; data analysis and probability; and algebra. The NAEP mathematics scale ranges from 0 to 500.

Overall Mathematics Results for Utah

- In 2007, the average scale score for eighth-grade students in Utah was 281. This was not significantly different from their average score in 2005 (279) and was higher than their average score in 1992 (274).¹
- Utah's average score (281) in 2007 was not significantly different from that of the nation's public schools (280).
- Of the 52 states and other jurisdictions that participated in the 2007 eighth-grade assessment, students' average scale score in Utah was higher than those in 17 jurisdictions, not significantly different from those in 12 jurisdictions, and lower than those in 22 jurisdictions.²
- The percentage of students in Utah who performed at or above the NAEP *Proficient* level was 32 percent in 2007. This percentage was not significantly different from that in 2005 (30 percent) and was greater than that in 1992 (22 percent).
- The percentage of students in Utah who performed at or above the NAEP *Basic* level was 72 percent in 2007. This percentage was not significantly different from that in 2005 (71 percent) and was greater than that in 1992 (67 percent).



Average Score Gaps Between Selected Groups

- In 2007, male students in Utah had an average score that was not significantly different from that of female students. In 1992, there was no significant difference between the average score of male and female students.
- Data are not reported for Black students in 2007, because reporting standards were not met. Therefore, the performance gap results are not reported.
- In 2007, Hispanic students had an average score that was lower than that of White students by 31 points. This performance gap was wider than that of 1992 (22 points).
- In 2007, students who were eligible for free/reduced-price school lunch, a proxy for poverty, had an average score that was lower than that of students who were not eligible for free/reduced-price school lunch by 20 points. This performance gap was wider than that of 1996 (12 points).
- In 2007, the score gap between students at the 75th percentile and students at the 25th percentile was 48 points. In 1992, the score gap between students at the 75th percentile and students at the 25th percentile was 43 points.

¹ Comparisons (higher/lower/narrower/wider/not different) are based on statistical tests. The .05 level was used for testing statistical significance. Statistical comparisons are calculated on the basis of unrounded scale scores or percentages. Comparisons across jurisdictions and comparisons with the nation or within a jurisdiction across years may be affected by differences in exclusion rates for students with disabilities (SD) and English language learners (ELL). The exclusion rates for SD and ELL in Utah were 2 percent and 1 percent in 2007, respectively. ² "Jurisdictions" refers to states and the District of Columbia and the Department of Defense Education Activity schools.
