


Overall Results

- In 2011, the average score of fourth-grade students in Oklahoma was 215. This was lower than the average score of 220 for public school students in the nation.
- The average score for students in Oklahoma in 2011 (215) was not significantly different from their average score in 2009 (217) and was lower than their average score in 1992 (220).
- In 2011, the score gap between students in Oklahoma at the 75th percentile and students at the 25th percentile was 44 points. This performance gap was not significantly different from that of 1992 (41 points).
- The percentage of students in Oklahoma who performed at or above the NAEP Proficient level was 27 percent in 2011. This percentage was not significantly different from that in 2009 (28 percent) and was not significantly different from that in 1992 (29 percent).
- The percentage of students in Oklahoma who performed at or above the NAEP Basic level was 64 percent in 2011. This percentage was not significantly different from that in 2009 (65 percent) and was not significantly different from that in 1992 (67 percent).


Achievement-Level Percentages and Average Score Results


Compare the Average Score in 2011 to Other States/Jurisdictions

- In 2011, the average score in **Oklahoma** (215) was
- lower than those in 35 states/jurisdictions
 - higher than those in 5 states/jurisdictions
 - not significantly different from those in 11 states/jurisdictions

Score Gaps for Student Groups

- In 2011, Black students had an average score that was 22 points lower than White students. This performance gap was not significantly different from that in 1992 (22 points).
- In 2011, Hispanic students had an average score that was 14 points lower than White students. This performance gap was not significantly different from that in 1992 (16 points).
- In 2011, female students in Oklahoma had an average score that was higher than male students by 6 points.
- In 2011, students who were eligible for free/reduced-price school lunch, an indicator of low family income, had an average score that was 20 points lower than students who were not eligible for free/reduced-price school lunch. This performance gap was not significantly different from that in 1998 (23 points).
