


Overall Results


- In 2019, the average score of fourth-grade students in District of Columbia was 235. This was lower than the average score of 240 for students in the nation.
- The average score for students in District of Columbia in 2019 (235) was higher than their average score in 2017 (231) and in 2000 (192).
- The percentage of students in District of Columbia who performed at or above the *NAEP Proficient* level was 34 percent in 2019. This percentage was not significantly different from that in 2017 (32 percent) and was higher than that in 2000 (5 percent).
- The percentage of students in District of Columbia who performed at or above the *NAEP Basic* level was 73 percent in 2019. This percentage was higher than that in 2017 (69 percent) and in 2000 (24 percent).

NOTE: NAEP achievement levels are to be used on a trial basis and should be interpreted and used with caution. Detail may not sum to totals because of rounding.


Compare the Average Score in 2019 to Other States/Jurisdictions

■ higher than those in 5 states/jurisdictions
■ not significantly different from those in 8 states/jurisdictions

Score Gaps for Student Groups

- In 2019, Black students had an average score that was 47 points lower than that for White students. This performance gap was narrower than that in 2000 (66 points).
- In 2019, Hispanic students had an average score that was 40 points lower than that for White students. This performance gap was narrower than that in 2000 (64 points).
- In 2019, male students in District of Columbia had an average score that was not significantly different from that for female students.
- In 2019, students who were eligible for the National School Lunch Program (NSLP), had an average score that was 32 points lower than that for students who were not eligible. This performance gap was that in 2000 (32 points).
